A BYLAW OF THE RURAL MUNICIPALITY OF PENSE NO. 160 TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO ESTABLISH ADDITIONAL CHARGES FOR THE HAMLET OF STONY BEACH

WHEREAS the Council may regulate the distribution and use of water in the municipality and may fix the price for the use thereof and the times of payment;

NOW THEREFORE, the Council of the Rural Municipality of Pense in the Province of Saskatchewan enacts as follows:

- 1. This bylaw shall be known as the "Stony Beach Water Utility Rate Bylaw".
- 2. All persons desiring to be supplied with water from the municipality's water supply system shall make application to the officials of the municipality. Each application shall be responsible for providing their own water meter.
- 3. If the water supply is shut off from the premises of a user for infringement of the provisions of this bylaw or for non-payment, same shall not be turned on until all penalties; fees, rates, charges and arrears have been paid.
- 4. The charges to be paid by the water consumer whose water service has been turned on shall be those set forth in **Schedule** "A" attached; provided however, that the minimum shall be payable in every case whether or not any water is consumed.
- 5. An infrastructure charge for the repair and maintenance of the waterline shall be applied as set forth in **Schedule "B"** attached.
- 6. The above-mentioned charges shall form a part of the accounts for water service.
- 7. Accounts for water service shall cover a period of two successive months, and shall be rendered in the month next following such period (upon the Municipality's receipt of the City of Regina water invoice). Accounts shall be paid within a period of 30 days from the date on which such accounts are rendered. If an account is not paid within the said period of 30 days, the water service may be cut off. When the water service is cut off the following fees shall apply:
 - a charge of \$75.00 to disconnect the water service
 - a charge of \$75.00 to reconnect the water service.
- 8. Bylaw No. 2018-03 is hereby repealed.

The rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval thereof being issued by the Local Government Committee.
