SPECIAL TAX BYLAW

BYLAW NO. 2023-01

A BYLAW TO AUTHORIZE A SPECIAL TAX TO PROVIDE STREET LIGHTING IN THE HAMLET OF STONY BEACH

The Council of the Rural Municipality of Pense No. 160 in the Province of Saskatchewan enacts as follows:

- 1. A Special Tax be levied against all benefiting lands, as per Appendix A for the purpose or service of providing street lighting in the hamlet of Stony Beach for the year 2023.
- 2. The street lighting service is hereby authorized on taxable property within the hamlet of Stony Beach.
- 3. The estimated cost of the street lighting service is \$589.80 for the hamlet of Stony Beach.
- 4. The tax rate per assessment to be levied against all assessed owners of land according to their respective assessment is 0.7877 mills for the hamlet of Stony Beach.
- 5. Any person who considers that an error or omission was made in the application or calculation of the special tax on his or her property may notify the municipality in writing by September 30, 2023 requesting the Council to review the application or calculation of the tax rate regarding the property in question.
- 6. The administrator will notify the persons, who have requested a review, of the time and date the Council will meet to hear and review the requests.
- 7. The taxes that are levied will be added to the tax roll as a special assessment against the property, when they become due and payable, and are recoverable in the same manner as other taxes.

8. Bylaw No. 2022-02 is hereby repealed.
