## BYLAW NO. 2015-13

## A BYLAW CONCERNING THE ERECTION OF HIGHWAY TRAFFIC SIGNS

The Council of the Rural Municipality of Pense No. 160 in the Province of Saskatchewan enacts as follows:

- 1. In this bylaw the expression "road" means any public highway within the municipality as defined in *The Highways and Transportation Act 1997*, other than a provincial highway as designated pursuant to such Act.
- 2. Yield signs shall be erected at the intersection of roadways at the following locations:

- <u>6.</u> All signs erected pursuant to Section 2, Section 3, Section 4 and Section 5 hereof shall be erected not less than three meters and not more than fifteen meters from the near edge of the intersected roadway.
- 7. The provisions of *The Traffic Safety Act* shall apply, wherever applicable, to every sign erected pursuant to Section 2, Section 3, Section 4 and Section 5.
- 8. No person shall alter, damage, remove, deface, knock down or tamper with any sign erected pursuant to this bylaw.
- <u>9.</u> Any person who violates any provision of this bylaw shall be guilty of an offence and shall be liable on summary conviction to the penalties in the General Penalty Bylaw of this municipality.
